Description Regents Item:	The school is requesting a grade expansion. They currently serve students in grades K-4 and would like to add 5-8 over the period 2016-17 to 2019-2020. Enrollment would grow from 300 in 2015-16 to 500 in 2019-2020.

The application for this school is being reviewed for possible action at an upcoming Board of Regents meeting.
